Is it actually possible for a chiropractic network management company to achieve the following value-creating elements simultaneously?:

- Respect the profession of chiropractic and the doctors who deliver care
- Increase reimbursement
- Build trust based relationships with all stakeholders doctors, insurance companies and patients
- Control costs and lower the insurance companies' overall spend by eliminating fraud and waste
- Allow doctors to treat without preauthorization and treatment plans
- Provide substantial financial support for state associations to further improve the profession
- Deliver results with 96% less revenue to SCC than what larger chiropractic companies charge

The answer is "yes." SecureCare has proven this is not only possible, but is what insurance companies and doctors desire. Our shared objective of transforming our profession is complex and very time consuming. There are large and ingrained forces fighting to prevent our model from taking root, but it takes long-term vision and commitment to achieve fundamental change.

## **SecureCare Updates**

### <u>SecureCare Minnesota</u>

Effective October 1, 2017, SecureCare will implement new reimbursement rates for doctors in Minnesota. We are pleased to report that 96% of our participating providers received rate increases ranging from 4% to



17%. In addition, Blue Cross and Blue Shield of Minnesota reduced its overall spend through the appropriate use of SecureCare analytics and the elimination of waste. Within a single year, SecureCare made great progress in organizing the chiropractic profession in Minnesota into a smoothly running network. We collaborated with the doctors and Blue Cross to create a true win/win outcome. This project proves once again that our model works and results in a brighter future and respect for chiropractic.

### SecureCare Announces Expanded Medicare Advantage Benefits

SecureCare is excited to announce that effective January 1, 2018 Blue Cross and Blue Shield of Nebraska will enhance the chiropractic benefit of their Medicare Advantage product. As part of this effort, doctors will, for the first time, be paid for office visits and x-rays in addition to CMT codes. This is a breakthrough event for chiropractic and helps lay the foundation for broader expansion of Medicare payments on a national level. SecureCare will work with Blue Cross to monitor and analyze outcomes, hopefully documenting lower costs and improved outcomes.

### SecureCare of Ohio

After careful consideration, SecureCare and the Ohio State Chiropractic Association (OSCA) have parted ways and the OSCA recently terminated its association agreement with SecureCare. At issue were expectations for contracts with insurance companies and the pace of business development in Ohio. After further discussion by association leadership, the OSCA reached out to SecureCare seeking to re-contract with us; however, SecureCare declined OSCA's request. SecureCare believes the best long term

outcome for chiropractic and our doctors is to give the OSCA time to focus and rebuild the Ohio association. In the meantime, SecureCare will continue to work on behalf of our Ohio network doctors.

### Midlands Choice PPO

SecureCare participating providers with access to the multi-state Midlands Choice PPO should log onto Valence Health and check the new and improved reimbursement rates!

### Catholic Health Initiatives (CHI Health) Update

SecureCare is pleased to announce that on January 1, 2018 SecureCare will become a Tier-1 provider in a new collaboration between CHI and Blue Cross Blue Shield of Nebraska. The new narrow network product named *"Blueprint Health"* will be the exclusive network for CHI employees.

In addition to the CHI employee base, large employer groups with 151+ employees will be able to obtain a group quote from Blue Cross Blue Shield. Historically, CHI has not allowed access to chiropractic services. The addition of SecureCare as a Tier-1 provider allows doctors access to the vast CHI Health employee and large-group patient base.

### **Doctor Dividends and Association Support**

With the end of our fiscal year, July 31, 2017, SecureCare will be releasing doctor dividend checks and association support checks to eligible partners. Over the last 10 years, SecureCare has returned millions of dollars back to doctors and the profession.

Once again, SecureCare will be a Platinum Sponsor at this year's COCSA event set for November 2-4, 2017, in Puerto Rico. In addition, SecureCare will sponsor COCSA'S luncheon at the event. ## The Opioid Crisis & the Role of Chiropractic Care

Drug overdoses killed roughly 64,000 people in the United States in 2016 and are the leading cause of death for Americans under 50. Approximately 50,000 of these deaths are the result of prescription opioids, synthetic opioids (fentanyl) and heroin. The epidemic of heroin and fentanyl overdoses relates directly to the prescription of opioids for chronic pain in the United States [1]. New data reported in the New York Times in June and updated this month show the problem is worsening, not improving.

National Blue Cross Blue Shield (BCBS) data from 2015 revealed that 21 percent of their members filled a prescription for opioids in that year [2]. Arkansas had the highest rate of opioid prescriptions filled at 28 percent. Between 2010 and 2016, opioid use disorder for BCBS members has skyrocketed by 493 percent.

So, what has been the driving force behind the increased use of opioids and in turn, the increase of opioid dependence? In 1986, Russell Portenoy, M.D. and Kathleen Foley, M.D. concluded that opioid maintenance therapy could be a safe and humane alternative to surgery or no treatment in those patients with intractable nonmalignant pain and no history of drug abuse [3]. A New England Journal of Medicine letter to the editor from two Boston-area researchers, Jane Porter and Hershel Jick, in 1980, also suggested that the rates of addiction from opioids was extremely low [4]. Over the years these items were repeatedly presented as justification for the use of opioids and have now been blamed for fueling the crisis.

Erin Krebs, M.D. and her colleagues at the Minneapolis Veterans Health Care System have recently performed a randomized clinical trial with long-term follow-up that compares the use of opioids with non-opioids for low back pain and painful osteoarthritis. It has concluded that opioids offer no better pain relief for these conditions than safer analgesics such as nonsteroidal anti-inflammatory drugs, acetaminophen and other non-opioid pain medications. The findings have yet to be published, but were presented at the 2017 meeting of the Society for General Internal Medicine (SGIM) in Washington, D.C.

The evidence is clear that continued use of prescription opioids for chronic pain results in disastrous outcomes and even with acute pain, these medications must be used judiciously. One question then becomes, how can chiropractic care take on a more prominent role in the treatment of both acute and chronic pain patients? The Foundation for Chiropractic Progress has developed a tremendous resource entitled, "Chiropractic, A Key to America's Opioid Exit Strategy" [5]. I would encourage you to read and understand this document and then be willing to educate decision makers in your direct periphery regarding chiropractic's role in the management of pain.

In addition, become familiar with other emerging data that supports the use of conservative non-drug chiropractic care for all types of pain. This includes the new guidelines developed by the American College of Physicians which recommends spinal manipulation, acupuncture, and massage as first-line therapies for acute and subacute back pain. SecureCare will continue to promote the expansion of conservative, cost-effective chiropractic care as we meet with current and future payer partners, but we depend on doctors in the field to also play a role in educating the public on these very important issues.
